## 2. Delivery Terms:

- 2.1 The Vendor are requested to submit their quote for all the specification which is given below. The Items should be readily available with the Vendor.
- 2.2 The Vendor shall strictly adhere to the delivery period of four (04) weeks from the date of Purchase Order (PO). Non-adherence to the delivery schedule may lead to cancellation of the order and/or imposition of a penalty at the rate of 0.5% of the work value per week of delay, subject to a maximum of 10% of the total work value. The decision of SETS in this regard shall be final and binding, and no further correspondence will be entertained.

## 3. SCOPE OF WORK/ SUPPLY:

The items to be supplied shall be in good working condition. All instruments shall carry a warranty of **three (03) years** from the date of successful commissioning. During the warranty period, any defects or faults shall be rectified or the equipment replaced by the vendor at no additional cost.

## 4. Site Visit Schedule:

We acknowledge that the vendor from the Society for Electronic Transactions and Security (SETS) will be visiting the site to assess the installation requirements. Kindly note that site visits may be scheduled from Monday to Friday, between 10:00 AM and 6:00 PM.

## 5. Payment Terms:

- 5.2 Payment shall be made through NEFT transfer within 10 (ten) working days from the date of successful installation and commissioning of the equipment.

5.3 The Invoice raised by vendor must contain GST Registration of SETS i.e. 33AACT56338P1ZY and relevant Purchase Order Number.

**6. Submission of Quotation:**

6.1 The Quotation can be submitted in the prescribed format (as per Annexure-A) as enclosed here with, either in sealed covers at Purchase Section of SETS on or before **08.10.2025 till 13:00 PM**. The quotation should be printed on letterhead of the Vendor duly signed by vendor.

6.2 The Quotations that are submitted after the prescribed date & time shall not be considered for evaluation.

6.3 The offered rates should be inclusive of delivery charges at SETS and any other charges but exclusive of applicable GST.

**6.4 The details of the firewall/specification, as requested in Annexure 1, are important. Vendors who do not submit this document will not be considered for evaluation.**

**6.5 Vendors, those who are willing to participate in the tender requires to submit the Authorized Dealer/Seller of models of brands which is being offered and has to submit the relevant supporting document from OEM for the same along with quote. Quotes received without the OEM certificate will not be considered.**
