- 2.2 The Vendor should strictly adhere to delivery period within four weeks from the date of PO. Non-adherence of delivery terms may lead to cancellation of order / imposing penalty of Rs.100 per day per IDA Pro Ultimate license for the delay period but subject to maximum of 10% of Work Value. SETS decision in this regard is final. No further correspondence shall be entertained in this regard.

3. SCOPE OF WORK/ SUPPLY:

The Instruments to be supplied shall be in good working condition. Warranty for all the instruments shall be for a period of One Year from the date of successful commissioning.

4. Payment Terms:

- 4.1 No advance or part payment will be done.
- 4.2 Payment will be done through NEFT within 10 working days from the date of receipt of Invoice at Purchase Section of SETS subject to certification of successful delivery of the materials / completion of Job at SETS.
- 4.3 The Invoice raised by vendor must contain GST Registration of SETS i.e. 33AACT56338P1ZY and relevant Purchase Order Number.

5. Submission of Quotation:

- 5.1 The Quotation can be submitted in the prescribed format (as per Annexure-A) as enclosed here with, either in sealed covers at Purchase Section of SETS on or before **01.09.2025 till 18:00 PM**. The quotation should be printed on letterhead of the Vendor duly signed by vendor.
- 5.2 It is SETS prerogative for extension of the quotation submission time.
- 5.3 The Quotations that are submitted after the prescribed time may not be considered for evaluation.
- 5.4 The offered rates should be inclusive of delivery charges at SETS and any other charges but exclusive of applicable GST.
- 5.5 The Offered rates should be valid for 60 days from the end date for submission of quotation.
- 5.6 The Vendor can submit quote for any one/ more products as per description above. The Items should be readily available with the Vendor.
- 5.7 Vendors, those who are willing to participate in the tender requires to submit the Authorized Dealer/Seller of models of brands which is being offered and has to submit the relevant supporting document from OEM for the same along with quote.
